

RULES AND REGULATIONS FOR PARTICIPANTS IN
EXTRA-CURRICULAR ACTIVITIES AT CASHION HIGH SCHOOL

2010-2011 SCHOOL YEAR

The extra-curricular program at Cashion High School includes the following activities: Athletics, Band, FCCLA, BPA, FFA, Student Council, Cheerleaders, Dances, Prom and Academic Team.

It is hoped that as a result of the extra-curricular program your child will grow physically and emotionally stronger. It is the desire of the school that students should be involved in an extra-curricular activity. Through participation in an activity a student should grow in their disciplined efforts, both individually and as a part of a group.

Certain standards of social behavior are expected from students participating in an extra-curricular activity at Cashion High School since they are more visible representatives of our school and community than the non-participants. As a result of this situation, the students should be governed by rules of conduct.

Because extra-curricular activities are disciplined activities and students choose to participate in these activities must be willing to discipline themselves and refrain from certain activities non-participants may be involved in. The following rules and regulations will apply to all organizations at Cashion High School. The following rules will be strictly enforced during the school year and students are expected to follow these rules during summer activities.

1. No use of tobacco in any forms; not only is this harmful to your health but is also against the Laws of Oklahoma for persons under 18 years of age.
2. Use of alcoholic beverages in any form will not be allowed, as this is dangerous to your health and is illegal under the Laws of Oklahoma.
3. Use of illegal drugs will result in immediate suspension from the organization.
4. Any action that would bring discredit upon our organization, school, or community will result in action being taken by the sponsor.

Students in violation of the above rules will have the following disciplinary action taken: All sponsors and administrators will report violations for disciplinary referral.

- A. First violation, parents will be notified and the first violation will result in a one week suspension from activities. Students being disciplined will be suspended from all extra-curricular activities sponsored by Cashion High School during the suspension period.
- B. Second violation, parents will be notified and the student will be suspended from the organization for the remainder of the season or semester, or six weeks whichever is the longest. Students being disciplined will be suspended from all extra-curricular activities sponsored by Cashion High School during the suspension period.
- C. Third violation, parents will be notified and the student will be suspended from the organization for one school year or 36 weeks whichever is longest. Students being disciplined will be suspended from all extra-curricular activities sponsored by Cashion High School during the suspension period.

We have gone to some length to formulate and explain the rules and hopefully there will be no misunderstandings. We do not want to discipline our students but we do want to reduce and/or prevent chemical, tobacco and alcohol use by students at Cashion High School. Our first concern is that the student who uses one of these substances gets help. The longer we can delay a student's use of any harmful substance the greater their chances of not being "hooked" on it later in life. If we can be of help please call.
